RENOVATION OF COURT COMPLEX VAVUNIYA

The Chairman of the MPC on behalf of the Ministry of Justice and National Integration (herein after referred to as “The Ministry”) invites sealed bids from eligible and qualified bidders to Renovation Of Court Complex Vavuniya for estimated cost **Rs.74.78 Million (without vat & Contingencies)**

01. Detailed description of the requirements and functional specifications of the above are given in the bidding document. (The Contract period is **300** days)
02. Bidding will be conducted using the National Competitive Bidding (NCB)

To be eligible for contract award the successful bidder shall not have been black listed and shall meet the C5, C4 or C3 CIDA/ ICTAD registration

03. Qualification requirements to qualify for contract award include:
 - a. Average annual volume of construction work performed in last five years shall be at **least Rs.107 Mn.**
 - b. The minimum amount of liquid assets and/ or credit facilities, after setting apart for the other contractual commitments and exclusive of any advance payments which may be made under the Contracts, shall be not less than **Rs.22 Mn.**
 - c. Experience in the construction of at least one contract of a nature and complexity equivalent to the Works over the last 5 years
04. Potential bidders should have fulfilled the **requirement of registration under the terms of the Public Contract Act No.03 of 1987**, along with the Bid submission.
06. Interested eligible bidders may obtain further information from **Chief Accountant (Procurement), Procurement Division, 1st Floor, Ministry of Justice and National Integration, No.19,Sri Sangaraja Mawatha, Colombo 10**, and may inspect the Bidding documents during the office hours (9.00 a.m. -3.00 p.m.) on week days (excluding national holidays) commencing from **30/07/2026** at the said Procurement Division, of the Ministry at the above address. **Telephone / Fax No.011-2438178**
07. Interested bidders may purchase a complete set of Bidding documents (available in English Language) from **30/07/2026 to 19/08/2026** during the office hours (9.00 a.m. - 3.00 p.m.) by submitting a written request to the **Secretary, Ministry of Justice and National Integration**, along with the Certificate of Registration under the aforesaid Public Contract Act (Paragraph 05), and upon payment of a nonrefundable fee of **Rs.12,500/-** to the **Procurement Division, 1st Floor, Ministry of Justice and National Integration, No.19,Sri Sangaraja Mawatha, Colombo 10.**

08. Bids shall be delivered in duplicate and may be,

- I. Forwarded under registered cover to the Chairman of Procurement Committee to the address mentioned below, and same to be reach the Ministry on or before 11.00am on **20/08/2026; or**
- II. Deposited in the Tender Box kept at the **Procurement Division, 1st Floor, Ministry of Justice and National Integration, No.19, Sri Sangaraja Mawatha, Colombo 10, on or before 11.00am on 20/08/2026;**

Late bids will be rejected. Bid sent in any other methods or electronically will not be accepted.

09. All bids must be accompanied by a “**Bid-Security**” in the form of bank guarantee, issued by any Commercial Bank approved by Central Bank of Sri Lanka which is of the format attached in the Bidding document for the following values of Sri Lankan Rupees. **Bid Security** shall be obtained in **favor of Secretary, Ministry of Justice and National Integration, 1st Floor, No.19, Sri Sangaraja Mawatha, Colombo 10** valid until **17.12.2026** Amount of the **Bid Security** is Rs.748,000.00. Any bid not accompanied by a valid Bid Security will be rejected.

Further information regarding the submission of bids are contained in the bidding documents.

10. Bids shall be valid until 19.11.2026.

11. Bidders must be submitted dully completed a Non-collusion Affidavit as per the procurement guideline 1.5.(Format is attached in the bid document.)

12. Bids will be opened immediately after the deadline for submission of bids, in the presence of the Bidders and/or their authorized representatives, who choose to attend in person at the address stated in Paragraph 08.

13. The Ministry will not be responsible for any cost or any expense incurred by the bidders in connection with the preparation or delivery of the bids.

14. Pre-bid meeting will be held on 10.08.2026 at 11.00am at Procurement Division 1st floor, Ministry of Justice and National Integration.

15. The final decision on this procurement rests on the Procurement Committee.
